The St Georges Basin Country Club Ltd does not usually disclose your personal information to any other organisation or person unless there is a legal requirement to do so. The Club may also disclose personal information to relevant authorities if it reasonably believes that there is a threat to an individual's life, health or safety, or public health or safety. If the Club has reason to suspect that unlawful activity has been, is being or may be engaged in, personal information may be used or disclosed as a necessary part of any investigation and reporting to relevant persons or authorities.

The Club may disclose your information to third parties that provide services under contract to the club. These contracts require the third party to keep your personal information confidential and secure in accordance with the Privacy Act 1988, the APPS and this policy.

Your personal information, including information about you obtained as a result of you placing your membership card in gaming machine or other club machine (not ATMs), may be used by the Club for marketing purposes to improve our services and to provide you with the latest information about those services, any related services and promotions.

If you do not wish to receive information about services and promotions, the Club, on request, will remove your name from the mailing lists.

You have the right to access personal information that the St Georges Basin Country Club Ltd may hold about you, including a right of correction of your information. All requests will be processed within a reasonable period and be made at the contact details provided below.
